# ASRS UPDATE BY STEVE RAMOS

### OUR PENSION BENEFITS COME UNDER ATTACK BY THE LEGIS-LATURE; LEGAL PROTECTIONS ARE CALLED "SENSELESS CON-STITUTIONAL STRAITJACKET" BY THE MEDIA.

A recent Arizona Supreme Court decision on pension benefits is both good news and bad news for AEA-Retired. The decision has confirmed the strength of the pension protection language AEA-Retired help put in the Arizona Constitution. Unfortunately, the decision only reinforces the belief of Representative John Kavanaugh (R) and others, that those constitutional protections go too far. Kavanaugh has introduced **HCR 2001**, a measure he plans to put on the ballot in November of 2014, that would allow for a reduction in member benefits when the legislature feels it is necessary. A decision to push ahead with **HCR 2001** may come in the next few weeks.

In a recent editorial referring to the court's decision affecting all Arizona pension systems, the Arizona Republic said, "it leaves Arizona taxpayers in a position of disturbing vulnerability, one that begs for a constitutional amendment that will allow lawmakers to make the sorts of changes the justices now say they cannot." That opinion was followed with this, from Arizona Republic columnist Bob Robb: "the mounting problem will be the crowding out effect paying these benefits has on the ability of government to do other things and the pressure that puts on taxes."

Preparing for pension attacks, AEA Retired has been working with other public employee groups to form the **Arizona Retirement Security Coalition**, with the purpose of defending and promoting our Defined Benefit pension plans and preparing for any campaign involving **HCR 2001**. We are asking all members to become informed and involved. You can begin that process by going to <a href="http://azretirementsecurity.com">http://azretirementsecurity.com</a>, where you can learn more about the campaign and register to get email updates on news and

activities. Also you can find us on facebook and "like" our page at https://www.facebook.com/arizonarsc . Finally, make sure AEA-Retired has your email, so you can receive "call to action" updates directly from AEA-Retired. AEA-Retired may also contact you about "call in" telephone town hall meetings, where information about the coalition campaign can be shared and questions answered.

AEA Retired members and leaders have had some success at the capitol this session, speaking out against bills that would create future liabilities in our ASRS fund and threaten the retirement security of all of our members: **HB 2049**, a bill that would have restricted pension calculations to an employee's base pay, excluding performance pay, bonus pay and other extra pay catagories, was killed in committee.

**HB 2090** a bill that would have allowed new hires to choose between the current Defined Benefit plan and a really bad 401k style Defined Contribution plan, was killed in committee.

**HB 2056** would eliminate the ability of retirees to Return to Work, either part time or full time. After AEA Retired expressed opposition, the bill disappeared and popped up in the Senate as **SB1240**, with language focused only on leased employees. The bill passed the Education Committee and is being watched closely.

# **Continue the Legacy: Support Stronger Education Standards**

You can take the teacher out of the classroom, but you can't take the classroom out of the teacher. The same old ad-

age can probably be applied to so many of us, no matter our calling, but I know this to be especially true of my colleagues. Certainly, as the years go by, we may not be able to remember the name of each and every student we taught, but a teacher, even a retired one, never stops thinking about his or her students and hoping for their success. Every day, teachers witness and

experience the power of impacting young people; when we help create strong, successful students, we are not only impacting their future, but also the future of our entire society.

We are all affected by and responsible for the continued growth of our young people, and for leaving the world better off for those who stand to inherit it. For many years, we have been proud to be able to say that we have accomplished this, but it is no longer true. The generations following ours are facing economic and employment instability. When our young adults leave school, many of them aren't prepared for college or careers and the technological changes requiring very different skills of the workforce. Most jobs in Arizona – more than 8 out of 10 in high growth, high wage fields – currently require some type of postsecondary education or training that demands these higher-level skills, yet we are not preparing our students for this new reality.

For our students to be successful in the workforce, competitive in the ever-growing global economy and positive contributors to our local communities, we must ensure our students have the best education we can provide for them. Arizona's new standards help us fulfill this obligation by raising expectations for all students and by fostering independent critical thinkers who are flexible in their analyses and problem solving skills. Supporting Arizona's efforts to implement higher academic standards for students through Arizona's College and Career Ready Standards (based on the Common Core State Standards) is vital to the success of our community as a whole.

To implement these standards appropriately, teachers must be given quality professional development, input into selecting appropriate teaching materials, time to develop the curriculums to match the standards, and freedom from being professionally evaluated by standardized student tests that have yet to be fully developed. To accomplish all of this requires time and funding.

As retirees, we may not be interacting with today's students as directly as we once were, but ensuring their success as they enter the workforce will always remain a priority for us. We will rely on these young people in a few short years. They are the professionals who will help rebuild the strong economy that we toiled so hard to build and maintain ourselves. We may have retired from our positions, but we will never retire from our profession, or from advocating for a quality public education for all of Arizona's students. The vehicle that will help to prepare our students for future success is Arizona's College and Career Ready Standards.

# **Failing Schools: Fact or Fiction?**

Many of our active AEA-Retired members started their teaching careers decades ago, and although teaching has never been easy, it was a career that was respected and rewarding. When asked, "What do you do?" answering, "I teach" always brought a smile and a nod. Sadly, that has changed.

Years ago a neighbor, a self-appointed expert on education lectured, "Teachers need to be held accountable!". Accountable? When had teachers not been accountable for what they taught? That became a buzzword which translated as teachers were goodfor-nothing-only-working-nine-months moochers.

In Dean Paton's article for Yes.org, online magazine, "The Myth Behind Public School Failure", <a href="http://www.yesmagazine.org/issues/education-uprising/the-myth-behind-public-school-failure">http://www.yesmagazine.org/issues/education-uprising/the-myth-behind-public-school-failure</a>, he exposes the sources and motives for the attacks on public schools and public school teachers. The myth is about money, or rather profit. Corporations discovered that public education was an untapped source to riches.

For over thirty years public schools have taken the heat for never doing enough, but Dean's article points out that that was the point. Educators were naïve, and the corporations were the tailors, a la, "The Emperor's New Clothes". They sold expensive, unworkable programs and technologies to desperate districts. When they didn't work, it was the teacher's fault, because teachers just didn't try hard enough. Teachers left teaching and even the most idealistic young people are not willing to enter the profession.

Forty years ago, advertising experts Jack Trout and Al Reis, wrote that word-of-mouth is the best way of spreading the truth, and it still can't be bought by huge companies at any price. Please consider sharing or posting Dean Paton's article where the heroic public educators triumph over the lust for profit.

# Good News from the White House

President Obama's Fiscal 2015 Budget will **not** include a switch to the Chained CPI formula that limits cost of living increases in Social Security. Many of you, along with groups all over the country, worked diligently to stop this change from being implemented. It was a victory for Seniors and a victory for grassroots politics. Now we need to work to expand Social Security so that it fits the retirement security needs of today.

# **Bad News from the State House**

So many bad bills have been introduced in our state legislature this year. Let's start with the debacle, SB 1062, which became the headline story across the nation causing Arizona's reputation to sink to a new low. Thankfully, Governor Brewer vetoed this hateful bill. The opposition to this bill from the majority of Arizona citizens, businesses and corporations was overwhelming, and will help to restore our image as a great state. This was another victory for grassroots politics.

There are many other bad bills that need our attention: bills that attack pubic education and education employees, and bills that attack our retirement system. One that we are watching carefully is HCR 2001, which would amend our state constitution to allow for reducing retirement benefits for those public employees currently retired or still working in the system. If this referendum passes the legislature, it will be on the November, 2014 ballot and could overturn our constitutional guarantees that were passed in 1998 with Proposition 100. Recent columns and editorials in the *Arizona Republic* newspaper have expressed support for such a change in the constitution, and also

changing to a Defined Contribution (401k) type of pension plan from our current superior Defined Benefit pension program.

We need your support. We need you to stay informed about pending legislation and the status of introduced bills, and then take action by supporting positive bills and taking action to oppose the many bad bills.

These changes are being recommended by the AEA-Retired Executive Board and will be voted on by the delegates at the Annual Meeting on April 25th. #### ARTICLE IV. MEMBERSHIP

#### Section 1.

Membership shall be open to any person who was formerly employed by a school district, college, university, educational institution, or related agency.

#### Section 5.

E. Individual Chapters will be responsible for setting their own dues (if any), agenda for meetings and programs, and their own governance document as they deem necessary.

#### ARTICLE V. OFFICERS

#### Section 2.

All officers shall be elected by secret ballot by the AEA- Retired elected delegates to the AEA Delegate Assembly. Newly elected officers shall enter upon their duties [immediately following the Annual Meeting] on June 1st.

#### Section 3

Officers shall serve for a term of three years, but limited to no more than six (6)

consecutive years in the same office. If an individual has been appointed to serve more than one-half of a term, it shall be considered a full term. Section 7.

In the event of a vacancy in the office of *vice president,* recording secretary and/or the treasurer, the president, with the approval of the Executive Board, shall choose a member of the Executive Board to serve in that capacity for the remainder of the term. More than half a term shall be considered a full term and individuals are then permitted to serve only one additional term. (revised 4/26/13)

#### Section 8

In the event of a vacancy in the position of representative-at-large, the president, with the approval of the Executive Board, shall appoint an AEA-Retired member to serve for the remainder of the term. *More than half a term shall be considered a full term and individuals* are then permitted to serve only one additional term. (Continued on page 6)

#### (Constitution & Bylaw proposed amendments continued from page 5)

#### Section 9

Should an officer of the AEA-Retired be elected to a different office on the Board during the regularly scheduled Annual Meeting, an election to fill the now vacated position shall take place prior to the adjournment of the Annual Meeting.

#### Section 10

Should a Representative-at-Large of the AEA-Retired be elected as an officer of the Board at a regularly scheduled Annual Meeting, the candidate with the most votes in the Representative-at-Large election who was not elected will automatically assume the vacant position.

#### ARTICLE VI. EXECUTIVE BOARD

#### Section 1

f. Any duly elected officer of NEA-Retired Executive Council

g. Any AEA-Retired members elected to the NEA Board of Directors

A. Representatives-at-Large shall be elected by secret ballot for a term of three

(3) years, and may only serve for two (2) consecutive terms for a total of six

(6) years. Representation shall be one (1) for each one hundred and twenty- five (125) members, or significant portion thereof. The minimum number of representatives shall be fifteen (15). Newly elected representatives shall enter upon their duties *on June 1st*. [immediately following the Annual General Meeting]. (4/12)

#### ARTICLE VII. AMENDMENTS

A. Amendments can be made by a two-thirds (2/3) majority of AEA-Retired elected delegates to the AEA Delegate Assembly voting in a regular election held at the General Membership Annual Meeting.

Note: All references to General Membership Meeting will be changed to General Membership Annual Meeting throughout the document.

#### **BYLAWS**

#### ARTICLE I. MEETINGS

Section 2. General Membership

[B. Special meetings of the membership may be called by the president or upon request of one-quarter (1/4) of the members for a special purpose; but no business other than that for which the meeting is called may be transacted.]

#### Section 3. Order of Business

The [order of] business of the General Membership Annual Meeting shall [be] include:

#### ARTICLE III. POWERS AND DUTIES OF THE OFFICERS

#### Section 1. President

A. With input from the Executive Board, set the agenda for all Executive Board and General Membership Annual meetings;

B. Fill all Board vacancies as delineated in the Constitution, Article V, with the approval of the Board.

#### Section 4. Treasurer

A. Submit a written report each meeting of the Executive Board and General Membership Annual Meeting;

#### Section 5. Representative- at -Large

The Representatives – at – Large shall:

A. [] Meet with the Attend Executive Board meetings [n a regular basis.]

B. Be available to Chair at least one Standing or Ad Hoc Committee

C. Assist with member recruitment and program development/delivery

D. Assist the Annual Meetings Committee in planning and implementing the Annual Meeting.

#### ARTICLE IV. POWERS AND DUTIES OF THE EXECUTIVE BOARD

A. Provide input to the president for setting [Set] the agenda for all Executive Board and General Membership Annual Meetings [and specially called meetings];

B. Set the annual dues.

C. Vote to approve the President's recommendation of [Appoint] an AEA-Retired member to fill vacancies [until the next regularly scheduled election.] for the remainder of the term.

#### Section 5. Standing Committees & Responsibilities

#### **B. Public Relations Committee**

[2. In cooperation with the Social Committee and the Annual Meeting Committee, be responsible for the location and arrangements for the General Membership meetings];

#### **B. Social Committee**

- [1. Shall be responsible, with the Public Relations Committee and the Annual Meeting Committee, for the location and arrangements for all General Membership Meetings];
- [2. Shall be responsible for all social functions of AEA- Retired; ]

#### C. [Legislative] *Political Action* [Committee]

- [1. Shall be responsible for the preparation of legislation of benefit to members; ]
- 2. Inform members of pending bills and work in cooperation with the Arizona Education Association's legislative goals;
- 3. On behalf of AEA-Retired, lobby legislators, other elected officials, and policy-makers as directed by the Executive Board.
- [4. And as directed by the Executive Board.]

#### **E. Annual Meeting Committee**

a. Coordinate with the Public Relations Committee and Social Committees to keep members informed of Annual Meeting details.

#### Section 6. Ad Hoc Committees

[A. A regional Ad Hoc Committee shall be formed and be responsible for development of regional participation and representation in AEA-Retired through the formation of Clusters.]
